**Subject:** Company S.A.Ba.R spa (Tax Code: 01589850351) - Determines to authorise waste management according to article 208 of D.Lgs. 152/2006 No. DET-AMB-2017-4621 on 4th September 2017 - Authorised financial guarantee.

This letter refers to the modification of the authorisation according to the article 208 for waste management, authorised with No. DET-AMB-2017-4621 of the 4th September 2017 to Company S.A.Ba.R spa for the plant located in the municipality of Novellara in Via Levata No. 64 and in the municipality of Cadelbosco Sopra.

The Company S.A.Ba.R spa, with note No. 236/MB dated 8th September 2017, and employed by PGRE No. 10502 on 8th September 2017 and relating to the authorisation of waste management according to article 208 of D.Lgs. 152/2006 No. DET-AMB-2017-4621 on 4th September 2017 has forwarded the financial guarantee by sending the appendix No. 12 dated 8th September 2017 to the financial guarantee No. 96/60738468 issued on 11th September 2017 by UNIPOL ASSICURAZIONI spa.
